Australians lose \$7.2m to computer-takeover scams in 2021

In the first six months of 2021 alone, Australians have lost a combined \$7.2 million due to computer-takeover scams, a [new report](#) from the Australian Competition and Consumer Commission (ACCC) has revealed. This figure is up by 184 per cent over the same period last year, with close to 6,500 independent reports of scammers trying to convince people to download software that would provide access to personal computers and bank accounts.

Critical manufacturing trades qualifications are being updated

With the increasing development of a modern manufacturing industry and the increasing skills issues being faced by business in Australia, it is essential that skills keep pace to meet the future needs of workers, employers and industry.

Clean Energy Careers Hub now live

Councils oppose infrastructure contributions rule changes

LGNSW is set to oppose infrastructure contribution rule changes that threaten to defer and reduce critical developer payments to councils at a Parliamentary inquiry. LGNSW President, Linda Scott, said the NSW Government had tried to sneak the changes through Parliament during the NSW Budget week in June to avoid scrutiny, but the peak association for councils successfully pushed back and the legislation was sent back to an Upper House Committee for review.

NAB backs growth of Australian Ag-Tech technology

NAB (National Australia Bank) has signed on as a Foundation Member of the Australian Agritech Association (AusAgritech) as it looks to help build a world-class agricultural technology (AgTech) sector in Australia. Through the two-year partnership, NAB will support AusAgritech in its goal of developing a \$20 billion a year AgTech industry. This will be critical in creating jobs and new export opportunities that will benefit regional Australia.
