Not trade marking your brand can result in tens to hundreds of thousands of dollars in rebranding or legal costs. [Holding a trade mark](#) protects you when selling online, allows you to license your products and increases your business valuation. Registering a trade mark only takes a couple of minutes and can be as cheap as \$330.

Feedback sought for NSW demolition regulations

The New South Wales Government has proposed new demolition licensing regulations that aim to strengthen safety standards and provide greater clarity.

Community feedback is being sought on the proposed changes to ensure that all stakeholders are heard before the new regulations are implemented. NSW Fair Trading Minister Eleni Petinos said that the demolition licensing regulation will move from the repealed Occupational Health and Safety Regulation 2001 (NSW) Act into the Work Health and Safety Regulation 2017 (NSW) Act.

Export Update: Roadshow highlights new export opportunities for India

Austrade and the Department of Foreign Affairs and Trade are hosting an India Market Update across Australia. It will highlight the potential benefits of the new Australia-India Economic Cooperation and Trade agreement. The roadshow will be in Brisbane, Adelaide, Hobart, Canberra and Melbourne during June.

Aussie consumers fearful over data security

The group surveyed more than 1000 Australians about their behaviours around data security and payments following the COVID-19 pandemic. The results showed 90% of consumers admitted their brand loyalty would come into question if their personal data was compromised as a result of poor data security practices, with 38% of people confirming they would avoid purchasing from the firm for a couple of months, 25% would avoid purchasing for several years, while 27% said they would never return to the business in question.
