CBA launches new dedicated support for tradies

Commonwealth Bank (CBA) has announced [new support for tradies](#) who are looking to start or grow their own business. Slower industry expansion shows need to address labour shortages

The Australian Industry Group (Ai Group) Australian PMI dropped by 1.5 points to 52.5 in July, indicating a weaker rate of expansion compared to the previous month. "The [supply and labour constraints](#) afflicting the Australian economy are weighing heavily on the manufacturing sector. Production and employment both fell in July, as manufacturers struggle with chronic labour shortages and supply chain interruptions," Ai Group chief executive Innes Willox said

Rising inflation prompts 'radical changes' in how Australians spend

Australians are set to make "[radical](#)" changes to their spending as the economy tightens according to new research by consumer intelligence platform, Toluna. To combat rising inflation and manage expenses, 20 per cent of Australians are now putting off upgrading their tech devices such as mobile phones and tablets, performing home repairs or buying any major appliances (18 per cent).
