Australia's first National Electric Vehicle Strategy released

The Federal Government has released Australia's first National Electric Vehicle

Strategy – a comprehensive roadmap to ensure Australians have a better choice of electric vehicles and encourage greater use of cleaner, cheaper-to-run vehicles. As part of the Strategy and following extensive public consultation, the Government will introduce a Fuel Efficiency Standard, working with industry and the community to finalise details in the coming months.

Brian Schmidt's big ideas for how Australia funds and uses research

Education makes Australian citizens healthier, wealthier and more engaged with society. At the same time, government-funded research in higher education drives economic productivity in ways other government funding does not. Together, the future of Australian prosperity depends on the education and research undertaken within its tertiary education system, and especially our universities.

Professional development support up to \$10,000 available for manufacturing workers

Applications are open for <u>support payments</u> worth between \$1,000 and \$10,000 through Manufacturing Skills Australia's Industry Development Fund. According to an invitation for nominees on MSA's website, the funding will help those "seeking support for individual skilling and development that is not supported by any other funding opportunity." Nominees can be aged between 15 and 65.

Weld Australia welcomes the Federal Government's Energy Apprenticeships Program

Weld Australia has welcomed the Federal Government's New Energy

Apprenticeships program, and the updated Australian Apprenticeships Priority List.

The financial support provided by the initiatives will be a drawcard for some businesses and apprentices. However, according to Weld Australia, much more must be done to tackle the nation's deficient of skilled welders.

Simply Cups program gains ARL recognition for paper cup recycling

Simply Cups, Australia's largest paper cup recycling program, has been recognised

as an <u>Alternative Destination</u> under the Australasian Recycling Label (ARL). Traditional curbside recycling programs do not accept paper cups, which often end up in landfills. The ARL gives consumers "easy-to-follow" instructions on which bin the cups should be placed in and an alternative destination option for specialised recycling programs, such as Simply Cups

FMCG: Australia's Healthy Food Report

Perhaps the one thing that every consumer from Gen Z to Baby Boomers agree on is that <u>eating healthily is incredibly important</u>. Their commitment to it has become a cornerstone of their value systems and how they live their lives. Australian Tax Office - Occupation and Industry Guides 2023

Our <u>occupation and industry guides</u> help you to complete your tax return, use these guides to: work out what income and allowances to declare; check if you can or can't claim work-related expenses as a deduction and find out what records you need to keep.

To claim a deduction for work-related expenses, you must meet the 3 golden rules:

You must have spent the money and you weren't reimbursed; The expense must directly relate to earning your income; You must <u>keep records</u> that show you incur the expense (usually a receipt)
