Australia's retail 'recession' runs to three consecutive quarters

New ABS data has revealed a third consecutive quarter of <u>declining retail</u> <u>sales</u> measured by volume, effectively showing the nation's 'retail recession' has now extended to nine months. Volume data excludes the impact of inflation on retail sales, which have been trending up for much of this year. The last time there were three consecutive quarters of declining retail volume sales was in 2008 – at the time of the Global Financial Crisis.
