MRFF awards \$50million to Australian Team developing artificial heart

The federal government has announced \$50 million from the Medical Research Future Fund (MRFF) to assist development and commercialisation of an Australian inventor's total artificial heart, which uses a rotor rather than pulsation to move blood through a patient's body. According to a statement on Tuesday from federal health minister Mark Butler, the grant to the Artificial Heart Frontiers Program was the third-largest in almost a decade of the MRFF's existence. The consortium involves five universities, three clinical partners, and BiVACOR

CSIRO, Standards Australia release new tool for understanding standards on hydrogen projects

CSIRO and Standards Australia have launched <u>HyStandards</u>, an interactive tool designed to provide the relevant Australian and international standards for hydrogen projects to industry users. CSIRO's Hydrogen Industry Mission leader, Dr Patrick Hartley, said HyStandards allowed users to choose from five different scenarios which then display a list of applicable standards. The scenarios are electrolyser hydrogen production, gaseous hydrogen transport by road, hydrogen transport by pipeline, blended hydrogen transport by pipeline, and hydrogen refuelling.

Plibersek prepared to step in if fashion industry doesn't step up on recycling

Environment Minister Tanya Plibersek says she's ready to regulate if more big fashion brands don't sign up to an industry-led scheme that plans to put a levy on garments to reduce the amount of clothing that goes to landfill. The Seamless scheme, launched by Plibersek in June last year and led by the Australian Fashion Council, aims to have 60 per cent of the clothing industry sign up by 2027 and has so far attracted brands including Big W, Cotton On Group, The Iconic and David Jones.
