The high road or the low road – by Dario Valenza

Dario Valenza charts some of the <u>impediments to manufacturing</u> and asks whether there is a path ahead, without sacrificing the things we value about Australia. Let's start by acknowledging that we have a high cost base in Australia because of geography, regulation, and taxation. Our geography dictates long supply-chains. So, the costs of getting raw materials and intermediate goods to and from manufacturing business, and finished goods to consumers, are necessarily relatively high.

I am pleased to announce the <u>Commission's Review</u> of small business experiences with regulatory policymaking. The Review will examine the experiences of small businesses as key stakeholders when new legislation, regulations, rules and other requirements are being developed. As part of the review, the Commission is seeking feedback from stakeholders on their experiences with regulation in NSW. By participating in our review, you can help us identify ways to better support our small business community. The 2024-25 Federal Budget was released in May which included an extension of the instant asset write-off.

Rino Recycling diverting construction waste from landfill

Brisbane's Rino Recycling is trumpeting the success of its \$95 million fully automated recycling plant at Pinkenba that turns construction and demolition waste into material for new infrastructure projects. Rino major projects manager Mat Stafford took to social media to reveal that the plant processed 17,386 tonnes of construction and demolition waste in a week with 94 percent of waste from landfill.

CEDA: The Migration Debate Striking the right balance

Cutting the permanent intake primarily detracts from migrants who are already in the country and is far from a <u>silver bullet</u> for housing. There must be greater stability and predictability through better planning and coordination, including with the states and territories.
